Magnolia FCU will re-open its branch lobbies **Thursday, May 7th**.
Our VA branch location will remain closed indefinitely.

In the last few weeks, we have taken a series of precautionary steps in response to the virus including increased cleaning and sanitizing procedures, hand sanitizer stations, plexiglass barriers for our tellers and MSR's, and floor decals to ensure we maintain proper distancing between our members waiting in line. We will also be limiting our branches to no more than 10 members at any given time.

Please note that should you choose to wear a face mask, you may be asked to remove it briefly in order to be identified. We also ask that if you have a fever or feel ill that you avoid our branches.

We appreciate your understanding and have introduced these measures both for the safety of our employees and members. While Magnolia has many goals and objectives, none are more important than your safety.

Mobile App – Download our Mobile App by searching Magnolia Federal Credit Union in the App Store or Google Play from your cell phone. The Mobile App can be used to move money between MagFed accounts securely, view balances, deposit checks, make bill payments, and skip a payment on eligible Magnolia loans.
