A Message From Our CEO

After much deliberation and careful analysis, Magnolia recently elected to discontinue our participation in the shared branching network.

This decision was made for the following primary reasons:

1) Member Wait Times - serving other credit union members in our branches stymies our ability to serve our own Magnolia members most expeditiously. We wanted to reduce our member's wait times in our branches.

2) It's Costly - Every time one of our members elected to perform a transaction at another credit union, Magnolia incurred a significant cost.

3) Available Alternatives - With our mobile and online banking enhancements, there are many alternatives to performing a shared branching transaction in a shared branching location, often without having to even leave your house.



4) Expansive ATM Network - if our members need cash, they have access to numerous ATMs around the country surcharge-free. To find an ATM in our network, simply go to our webpage www.magfedcu.org and select "Locations".

5) Call Center - Magnolia has a seasoned call center staff ready to assist you with any transactions you need help with or questions you may have. Call us at 800-997-7919 or email us at info@magfedcu.org.

Together We Can Achieve More

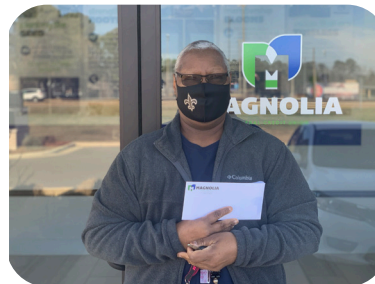

Spring Clean Your Finances

Sweep Out Your Budget
